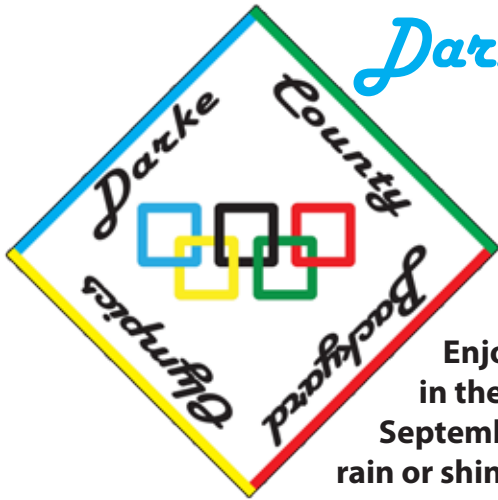


# Darke County Backyard Olympics
